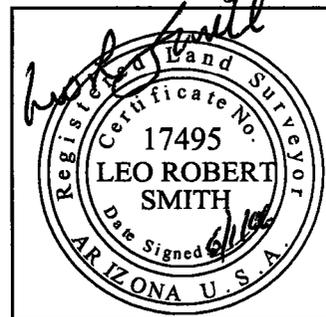

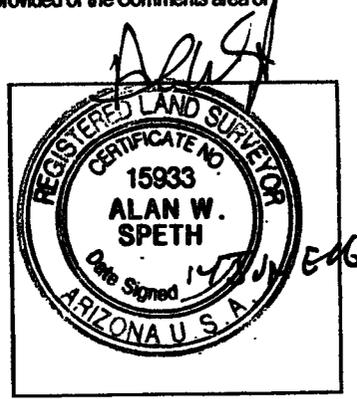

Pima County has requested several land surveyors, including myself, to go back and change, correct or revise elevation certificates that may have been missing or incorrect on the old (expired) forms, so you can understand my reluctance in filling out this form.

As per your request we have returned to this site and have taken additional elevation shots, away from (not adjacent to) the house/garage and here is what we found.

Drainage is generally in a Northerly or Northwesterly direction in this vicinity.

Using the FFE of the existing house as 100.00 the attached garage, to the South, is at an elevation of 99.9.

It appears as if the ground, Northwest of the Northwest corner of the house and about 70 feet away is at an elevation of 97.8 (greater then 2.0 required). The elevation of the ground 40 feet West of the Southwest corner is at 97.7

From the Southwest corner of the house/garage Southerly about 40 feet the ground is at an elevation of 99.2 (less then the required 2.0) before it starts to rise.

From the Southeasterly corner of the house/garage to the East (toward the road) there is a drop in the ground of about 1.5 feet to an elevation of 98.5 and is pretty consistent back around to the Northwest corner of the house

The pictures that we have taken of your house and garage do not show much, but you are welcome to them

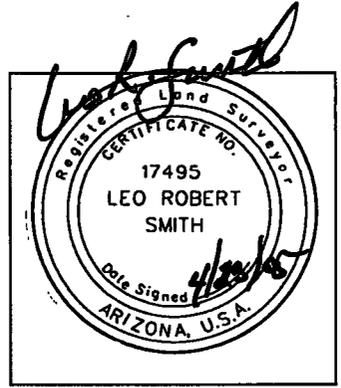

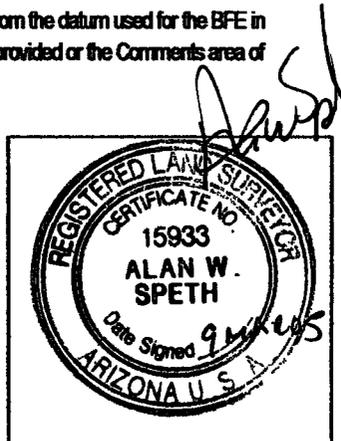
