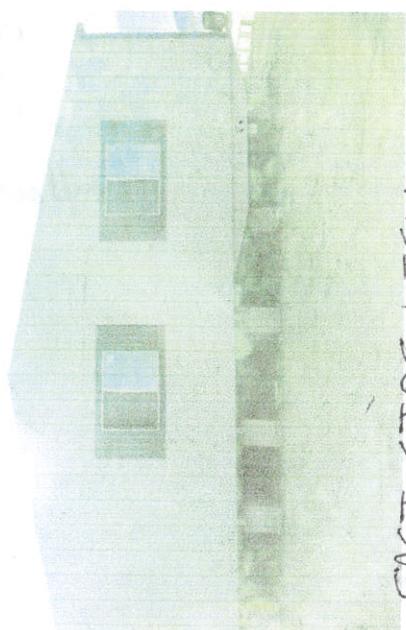
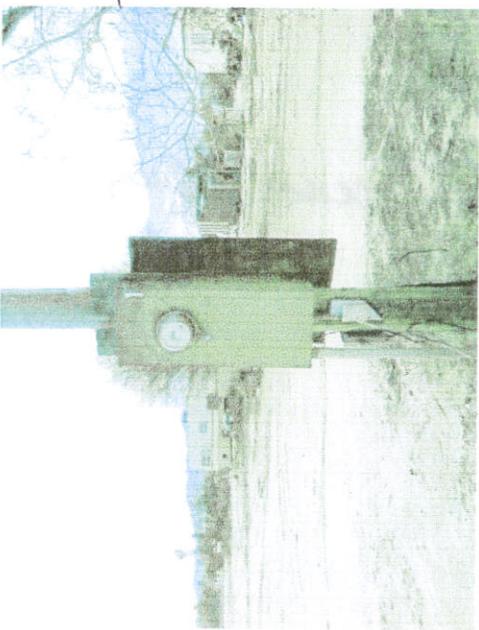

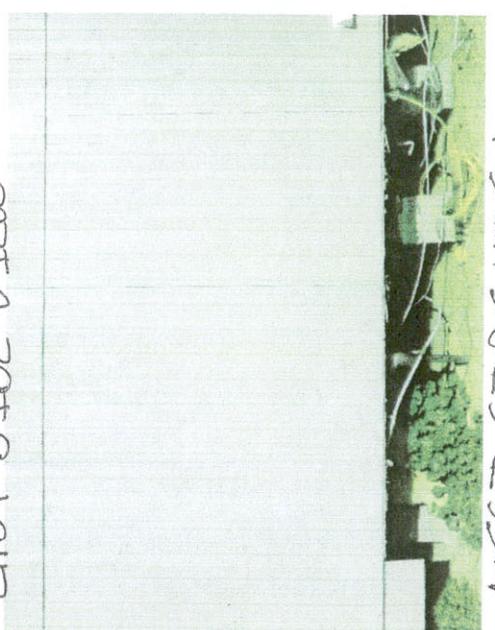
REAR VIEW
