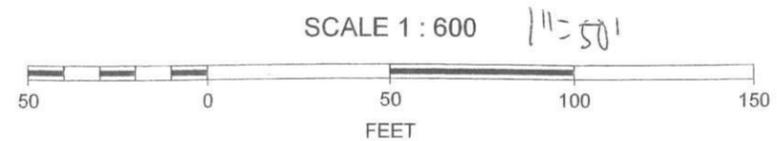






THREE FLOOD VENTS ON EAST WALL AND THREE FLOOD VENTS ON WEST WALL

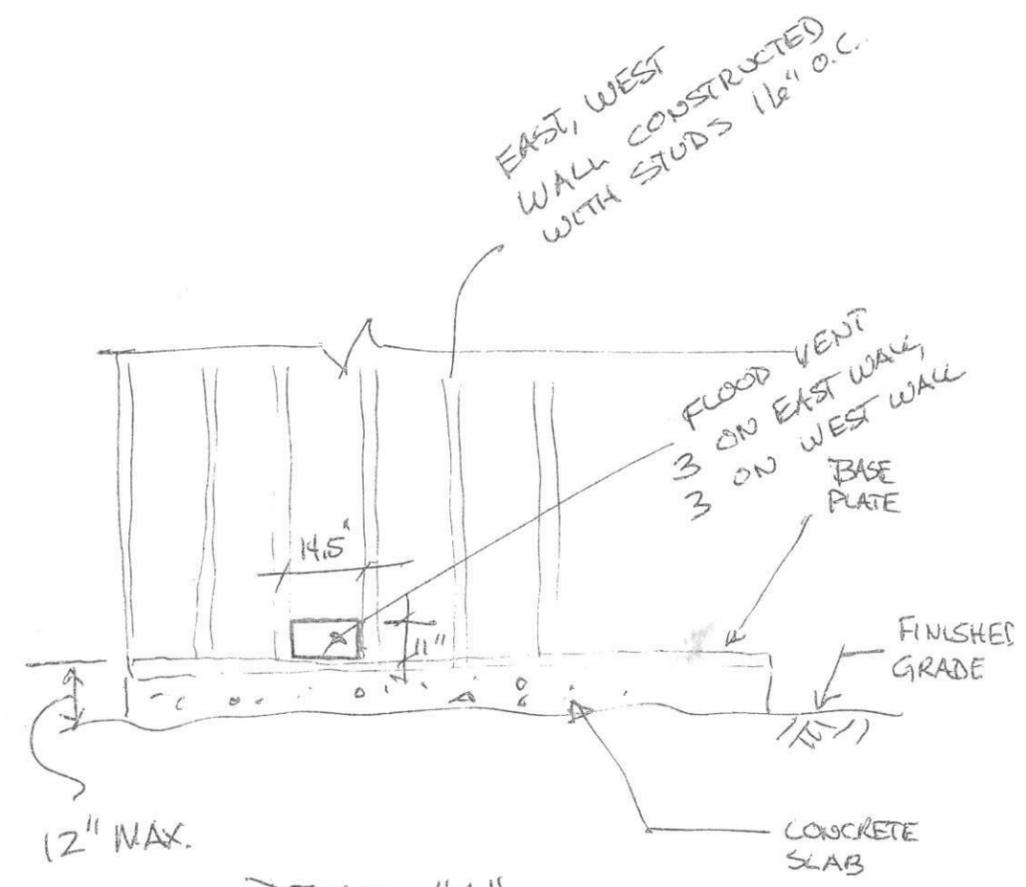
